# **Church Description**

Grant Memorial Baptist Church ("GMBC"), a member of the Baptist General Conference of Canada, is a vibrant, evangelical congregation, averaging 1,100 in two Sunday morning services. Over 1500 adults consider GMBC to be their home church. GMBC is known for its emphasis on teaching the Scriptures and diverse ministry engagement opportunities.

# **Job Summary:**

The Child and Youth Worker is responsible to assist in the development of a mid-week summer program for students grade 5-12. Grant Memorial Baptist Church embraces a philosophy of Family Ministry that strives to equip family leaders to be the primary disciplemakers in order to cultivate lasting faith in children and youth. In keeping with this, the Family Ministry Summer Intern will work closely with all staff members of the Family Ministry team to help achieve this goal.

# Time Requirements:

This is a short-term position of 35 hours weekly, from May 21st, 2024 to August 15th, 2024. Some evenings will be required. For this position, Sunday is considered a regular workday.

## Responsibilities:

- Assist in planning and implementing the mid-week summer ministry events for students in grades 5-12. (Multiply-Grades 5-7; and Heart & Soul-Grades 8-12)
- Assist in Sunday morning Kids Ministry, working alongside youth volunteers.
- Participate in vision casting and developing future outreaches, events and activities.
- Communicate with parents and volunteers in both written and verbal forms
- Collaborate regularly with the family ministry team (Kids Ministry and Youth Ministry teams) and provide support where needed.
